The reader who is primarily interested in a deeper understanding of the theoretical and practical aspects of Correspondence Analysis is directed to PARTS A+B+C+D, with additional reference material in PARTS E+F on the underlying philosophy of the method and comparisons with other methods. Finally, the reader interested primarily in the concepts and underlying philosophies of Correspondence Analysis is directed to PARTS A+E+F.
